Appointment of Directors According to the Companies Act, only an individual can be appointed as a member of the board of directors. Usually, the appointment of directors is done by shareholders. A company, association, a legal firm with an artificial legal personality cannot be appointed as a director.

Appointment of Directors: Managing Director, Shareholders ...

Any special approval requirements will need to be incorporated into this resolution. Section 159(1) of the Companies Act 1993 requires the company to notify the Registrar of Companies when a new director is appointed within 20 working days after that appointment. This can be done online via the Companies Office website.
