There are three types of dental plans available, prepaid, indemnity, and PPO: Prepaid Plans: DeltaCare USA, MetLife,* Premier Access, and Western Dental. A prepaid plan requires you and your eligible dependents to use a dentist from a specific list of dentists who are located in California and who contract with your selected prepaid carrier.

Keep in mind: DeltaCare and Willamette Dental Group are managed-care plans. You must choose a primary dental provider within their networks.
